Puri Konark Development Authority invites Expression of Interest in sealed covers from the intending Architect/Firms having Registration from the appropriate authority to prepare DPR and offer consultancy services for implementation of Projects under SRRH(Slum Rehabilitation and Redevelopment Housing Scheme at various locations in Puri urban area.
